Enrollment for the New Academic Session 2024 - 25

Enrollment for the New Academic Session 2024 – 25 for Class VI (Current V) will be done on **Sunday, March 24**, **2024**. Pending fees, if any, must be cleared before enrollment. Enrollment for the new session is compulsory since it is required for the school to make adequate arrangements concerning the recruitment of teachers, planning for timetables, filling vacancies. - 1. Metas Adventist School, Surat is under the purview of the Gujarat Self-Financed School (Regulation of Fees) Act, 2017 (Gujarat Act No. 20 of 2017).
